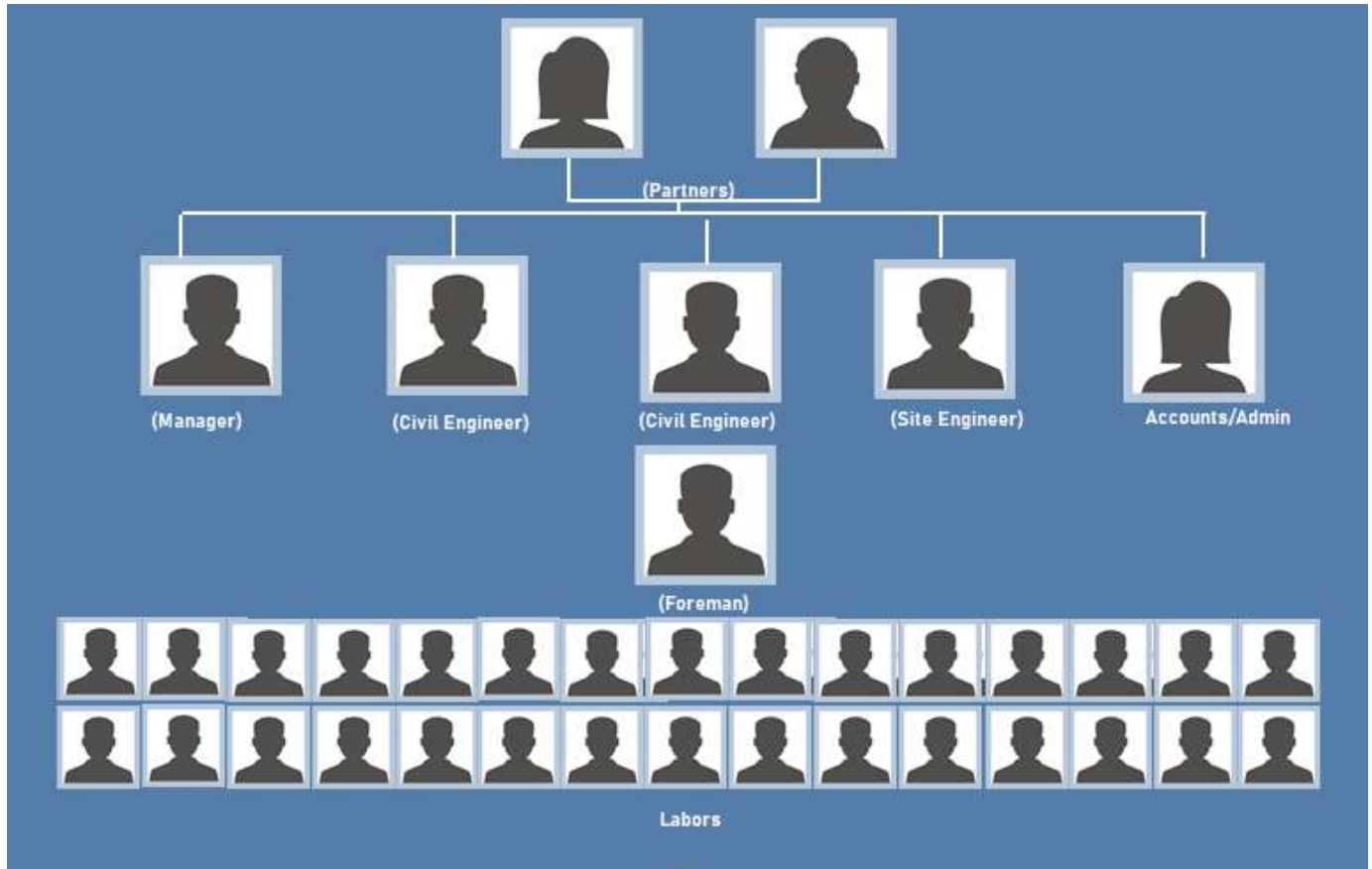

1. INTRODUCTION

This Requirement for the Management of HEALTH, SAFETY AND ENVIRONMENT (HSE) and associated Contracts, Legislation, Codes of Practice, Guidelines, Standards, Procedures and References identifies and encompasses the working behaviors and safe work practices that are mandatory for the project.

The HSE Plan defines the strategies that shall be used by KSK Constructions L.L.C Project Management to manage the safety and environmental performance of KSK Constructions

L.L.C personnel, Consultants, Sub-Contractors, Vendors and Visitors.

KSK Constructions L.L.C is legally responsible for ensuring conformance to all applicable aspects of Legislation and best international practices. If in dispute with any requirement the most stringent requirement shall apply.

KSK Constructions L.L.C policy accords safety the highest priority. Site safety requirements are laid down to ensure:

- Safe systems of work
- Safe plant and equipment
- Safe means of handling, transporting and storage of materials and hazardous substances
- Adequate training, instruction, information, and supervision
- A safe place of work with safe access to and egress from the place of work
- A safe and healthy environment
- Adequate welfare facilities

The policy has been written to assist KSK Constructions L.L.C and their employees, Consultants, sub-contractors, vendors, and visitors to play their part in maintaining the highest possible standards of safe working, and to advise safety requirements for the project.

KSK Constructions L.L.C have safe working practices however there are various regulations applicable to the work, which shall be met, over and above the requirements contained herein.

2. HSE STANDARDS AND HIERARCHY

Hierarchy

KSK Constructions L.L.C HSE standards for the Project Contract Scope of Work will follow the following hierarchy:

- Local HSE regulations and guidelines
- Client/Consultant HSE Guidelines
- Contract Requirements - KSK Constructions L.L.C HSE Policy and Procedures
- OSHA Standards



3. ORGANIZATION RESPONSIBILITIES & ACCOUNTABILITIES

Roles, Responsibilities and Accountabilities

KSK Constructions L.L.C Project Management team shall visibly demonstrate their commitment to the safety, health, and welfare of all stakeholders in the project, and shall demonstrate leadership in achieving the highest attainable standard.

KSK Constructions L.L.C Project Management team shall engage through consultation the vendors, consultants, sub-contractors, and their personnel engaged on the project to commit to these same safety, health, environmental and welfare goals.

To achieve this commitment KSK Constructions L.L.C Project Management shall take account of three key aspects which shall be present concurrently for this requirement to be fully implemented. These being:

- People - Safety Culture, Line Management Leadership, Training, Accountability, Individual Responsibility, Discipline, Employee Involvement, etc.
- Administrative - Standards, Systems, Procedures, Rules, Work Processes, QA, Audits, Operating Discipline, Change Management, etc.
- Engineering - Physical Design, Integrity and Capability, Handrails, Guards, Interlocks, Control Systems, etc.

KSK Constructions L.L.C Project Management team together with the vendors, consultants, sub- contractors, and their personnel engaged on the project shall ensure that these aspects are present and are evenly balanced to obtain the maximum performance achievable.

The values supporting this commitment are that:

- Management encourages involvement and ownership leading by example.
- Working safely is a condition of employment.
- Employee involvement and consultation is essential.
- All levels of management are accountable for managing safety, environmental and health issues.
- Hazards shall be identified, assessed, and controlled.
- Training employees to work safely is essential.
- Recognizing and rewarding employees.
- Providing employees with the resources required.

KSK Constructions L.L.C management believes that its active involvement in HSE affairs and administration will encourage all levels of line managers and supervisors in



the organization to give their full support and commitment to leadership and accountability. KSK Constructions L.L.C Project Management will visibly demonstrate unity of purpose and the direction of the organization on all HSE issues.

KSK Constructions L.L.C Management shall:

- Identify risks to Health, Safety and Environment and develop mitigation/control plans and communicate these to workers
- Reinforce safe work practices.
- Ensure Consultants, sub-Contractors comply with Client, KSK Constructions L.L.C and statutory HSE requirements.
- Place HSE high in the meeting agenda.
- Allocate adequate resources for HSE management and implementation
- Develop HSE targets and objectives and measure and review performance.
- Facilitate audits (internal and external) and implement audit recommendations that will address gaps and shortfalls in the system.
- Foster positive HSE culture and behavior.
- Treat HSE as a core value equal in importance with productivity, quality and ethical standards.
- Participate in HSE meetings and safety walkabouts.
- Develop efficient contingency plans and allocate adequate emergency resources
- Provide trained and competent workforce.
- Promote personal health and well being

4. HSE COMMUNICATION

HSE Induction Orientation and Training

KSK Constructions L.L.C will ensure that employees, sub-contractors, and visitors to the site are given adequate health, safety and environmental training who enter the site and shall stick "safety induction" sticker on his/her safety helmet certifying the individual has attended the course.

All employees will be informed of the changes in health, safety, and environmental legislation. Briefings on any changes to the legislation will be given verbally and/or in writing and it is the responsibility of all employees to familiarize themselves with changes in HSE legislation and procedures etc.

All employees will attend health safety and environmental courses, refreshers and awareness training corresponding to the level of their responsibilities as and when required to ensure their continued competence. Induction will be conducted for employees, supervisors, managers, and visitors.



Only trained and competent workers will be allowed to carry out the work for which they received training.

All new workers and visitors will receive induction training including a review of main hazards and HSE rules. Similarly, those transferring from one job or site to another will be given any necessary safety information. The induction will be conducted in a language of the majority of those attending.

KSK Constructions L.L.C Director will ensure that all employees including sub-contractors under his control have received induction training on the job.

The induction training shall cover, but not be limited to, the following topics:

- General site rules and regulations
- Security arrangements
- Electricity
- Responsibilities
- Training
- Permit to Work Systems - Work at height, Hot works, Confine Space, Excavation
- House keeping
- First Aid
- Accident
- Any task-specific hazards applicable to the inductees.

Once the site induction has been completed a sticker will be issued and placed on the side of their safety helmet.

Site Rules

The site safety rules are provided below and are for the protection of everyone, they apply to all persons on the site, including visitors and non-compliance will mean exclusion from the site. These rules will be communicated in the site induction. Visitors should be handed a copy of these rules prior to accessing the site and translations of all the Site Rules in the most common language and writing should be provided for the benefit of the operatives and be displayed on the site HSE notice board.

General Site Rules

- All personnel will undergo induction training.
- The minimum PPE for the project is, safety boots, Coveralls, Hard hat, high visibility vest, adequate hand, and eye protection.
- Every incident and „near miss“ event will be reported to the consultant and



project team as per the requirements.

- Every incident and „near miss“ event will be investigated and recorded and reports with root-cause, corrective and preventive actions will be circulated to consultant and project team
- Any person found to be interfering or misusing fixtures, fittings or equipment provided in the interest of health, safety, Environment, Security, or welfare will face disciplinary action.
- Smoking is restricted to designated areas that will be clearly marked on site.
- Visitors who come to the site must first undergo an induction then be escorted around the site. While on site, visitors are to always wear the appropriate PPE and follow the site rules
- Drivers of delivery vehicles will undergo an induction and must be in possession of their PPE and wear it when in or out of the vehicle, Failure to have the correct PPE will result in the vehicle and driver being removed from site
- Vehicles are not to reverse without banksman
- Health Safety, Environment, and Security signs and notices must be followed.
- Transistor radios or personal stereos/I-pods are not to be used.
- Permission must be obtained from the Employer prior to any photography or video filming on site.
- Site fire and emergency alarms, equipment and instructions are designed to protect life and must be always adhered to.

Meetings

Bi-Weekly management safety and environmental meetings

These meetings will be chaired by KSK Constructions L.L.C and attended by all sub-contractors to review any accidents, Safety Violation, Safety Audits, and other safety specific topics. Minutes from these meetings will be distributed by KSK Constructions L.L.C to all parties identifying specific action required.

Toolbox Meetings

The Toolbox meetings will be conducted by the KSK Constructions L.L.C for specific areas of operation and under the direction of the Field Engineer/Superintendent/Foremen in charge of the area. It will be attended by the Safety Manager or Representative and the Labor engaged within the area. Separate sub-contractor TBT meeting will be conducted, discipline and trade wise, by the sub- contractor engineers / safety officer which is attended by KSK Constructions L.L.C HSE Manager or his representative if required.



The meetings will address safety topics relevant to on-going operations and concerns raised in the bi-weekly HSE meeting. Safety Managers' inspection checklists and any safety violations or accidents will be reviewed, and preventive measures discussed. Positive comments and suggestions related to safety and the environment will be solicited. The meetings will be conducted by the Contractor; Records of these meetings along with contents will be kept by the Project HSE team.

Emergency HSE Meeting

Emergency meetings will be called in response to a stop work notice issuance or a major accident, incident, or near miss. Attendance is mandatory for KSK Constructions L.L.C, Contractor Project Manager, and all levels of subcontractors involved. The purpose of the meeting will be to identify root causes and formulate an action plan for prevention. This meeting must be successfully completed before work may begin. The place and time for the meeting will be arranged by KSK Constructions L.L.C.

5. HEALTH & WELFARE ARRANGEMENTS

KSK Constructions L.L.C shall ensure, as far as is reasonably practicable, the health, safety and welfare of all employees, subcontractors and those who visit their premises.

KSK Constructions L.L.C shall make sure suitable accommodation and welfare facilities are provided from the start and maintained throughout the construction phase. In accordance with employer's requirements.

All facilities will be constructed of flame retardant, non-combustible materials.

All facilities shall be fitted with adequate automatic fire detection, alarm systems and extinguishing medium.

Layout and specifications to be submitted to the SC and the employer for review and approval.

All facilities shall be Civil Defense compliant.



6. SAFE WORK PRACTICES (SWP)

The work scope for the project will involve the performance of activities that will necessitate, among others, the strict observance of established safe work practices. Guidelines for typical construction activities shall be provided before starting work on site.

Personal Protective Equipment (PPE)

It is an absolute requirement that safety shoes, helmet, reflective vest, Cover all, Hand gloves and Safety Goggles are worn whilst on site.

Other task-specific PPE must be identified in the Method Statement and/or Risk Assessment and must be used.

A check list which is completed bi-weekly will assess the use of PPE on site.

Working in short pants, without a shirt or in an undershirt, etc., is prohibited. Loose clothing must not be worn where it might become entangled with rotating equipment or otherwise present a hazard.

Any protective equipment that becomes damaged or worn shall be replaced.

All workers shall be trained in the proper use and limitations of the protective equipment provided.

- Protective clothing required for welding and burning varies with the size, nature, and location of the work to be performed.
- Only fire-resistant clothing must be worn.
- All welders shall use flameproof gloves.
- Clothes should be free from oil and grease
- Flameproof leather (or suitable material) aprons should be considered if long-term exposure to radiant heat or sparks is anticipated.

Respiratory Protection

Respiratory protection such as dust masks and particulate respirators will be provided by the Contractor to suit construction activities. Training will be provided by the Contractor associated with the proper use of this equipment.



Safety Signage

Safety signs and notices give a particular message to those who may be exposed to hazards associated with the work environment. This can prevent incidents, signify health hazards, indicate the location of safety and fire protection equipment, or for giving guidance and instruction in an emergency.

Definitions

'Safety sign' - a sign, warning colour, acoustic or hand signal referring to a specific object, activity, or situation, as well as verbal communication that provides information about safety in the workplace.

Signboard' - a specific object, activity or situation providing information (warning) about a hazard or danger to HSE at work, a prohibition, a mandatory action, an escape route or the location of fire-fighting and first-aid equipment.

KSK Constructions L.L.C will provide specific safety signs wherever there is a risk that cannot be controlled by any other means, e.g., by engineering controls and safe systems of work.

- Prohibition sign - prohibits activity that may cause a dangerous situation
- Warning sign - warning of a risk or hazard
- Mandatory sign - prescribes specific behavior and PPE levels
- A first-aid, emergency exits and additional escape routes sign - provides information regarding first-aid provision facilities, emergency exits and additional escape routes
- Fire safety sign - provides information regarding fire-fighting equipment and devices, and the location thereof in plans for evacuation, firefighting, rescue, and civil defense measures
- Information sign - provides additional information regarding the signs





Signage will contain a symbol or pictogram and be in a specified colour that clearly defines its meaning. Supplementary text may also be used to aid understanding

The following shall be used on a permanent basis:

- Signs related to prohibitions, warnings, mandatory instructions, and fire safety, as well as first-aid, evacuation, and additional escape routes
- Safety signs on containers and pipelines



- Warning colour or safety signs for indicating places where there is a risk of collision with obstacles, falling or there is a threat of falling objects
- Warning colour for marking traffic routes - road traffic signs must be used where necessary to regulate road traffic within the workplace.

Temporary Power Sources

All sources of temporary power (electrical, air, etc.) shall be properly installed and maintained in good condition. All distribution lines must be properly supported and shall not constitute a hazard to the workers. DB's will be adequately protected by hard barricades and protected from the elements all boards will have the emergency contact number of electrical foremen posted. Check list will monitor the temporary electrics.



Electricity

Workers shall not work on or be near energized circuits of any voltage unless adequate safety measures have been taken and the work operation has been reviewed and approved by the H&S Manager and a permit to work system established. Only competent persons shall be allowed to work on or repair electrical equipment.

All electrical installations shall comply with current regulations.

All tungsten-halogen lamps must be fitted with a glass guard to the element. These lamps must be permanently fixed at high level.

In addition to the above KSK Constructions L.L.C and its subcontractor will ensure the below mentioned with regards to the Temporary Electrical works Electrical installations on this Project will conform to the requirements of the relevant/current regulations / guidelines

Electrical and power tools that are operated on a Project must be given the respect deserved, as experience has shown that many fatal and disabling accidents have resulted from poor maintenance and poor work procedures.

All electrical tools shall be battery or 220V unless prior exemptions are granted.

Scaffolding

Scaffolding shall be erected by competent workmen possessing adequate experience and qualifications of such work. KSK Constructions L.L.C will ensure that all the scaffold erectors are trained and certified by the competent third party before mobilizing these workers to the site. An experienced, certified scaffold supervisor shall supervise the erection. Scaffolding shall be erected in line with the relevant OSHA Standards and legislative requirements.

A "Scaff tag" comprises a plastic holder, with a 50mm diameter hole, which can be threaded on to a scaffold tube and built into a scaffold structure. The holder is marked red-do not use scaffold. A green/yellow insert is then used to indicate a safe scaffold and the date of inspection.

- KSK Constructions L.L.C will ensure that safe and defined access is provided to all work areas. Ladders and scaffold materials shall conform to the applicable standards and the same can be inspected on the monthly basis and recorded
